# Meeting of the National Council for Conditions of Work (NCCW), Held on October 31, 2025

- 3. Discussion of a draft Regulation amending and supplementing Regulation No. 9 of 4.08.2006 on the protection of workers from risks associated with exposure to asbestos at work.
- 4. Discussion of a proposal by the Confederation of Employers and Industrialists in Bulgaria to change the employer representative in the National Council on Working Conditions and the Board of the Working Conditions Fund.
- 5. Discussion of a proposal for redistribution of funds under the Program for the Activities of the Working Conditions Fund for 2025.

# The following decisions were made during the meeting:

#### On point 1.

The NCCW adopts the draft Regulation amending Regulation No. 11 of 21.12.2005 on determining the terms and conditions for providing free food and/or supplements thereto and proposes to establish a working group that, by the end of 2026, will update the value of free food and/or supplements thereto and of tonic and invigorating drinks.

### On point 2.

The NCCW adopts the draft Regulation amending Regulation No. 8 of 26.11.2007 on the terms and conditions for financing the diagnosis of occupational diseases from the Working Conditions Fund.

#### On point 3.

The NCCW adopts the draft Regulation amending and supplementing Regulation No. 9 of 4.08.2006 on the protection of workers from risks related to exposure to asbestos at work.

#### On point 4.

The NCCW elects Ms. Vessela Bahchevanova as a member of the Management Board of the Working Conditions Fund, effective from 1 December 2025, in place of Mr. Evgeniy Ivanov, as a representative of the Confederation of Employers and Industrialists in Bulgaria.

# On point 5.

- 1. The NCCW accepts for consideration the Report on the activities of the Working Conditions Fund for the period 01.01.2025 30.09.2025.
- 2. The NCCW accepts the proposal of the Management Board of the Working Conditions Fund for the redistribution of funds under the Working Conditions Fund Program for 2025.

# On point 6.

The participation of the Working Conditions Fund in the co-financing of projects of enterprises to improve their working conditions shall be up to 30% of the project value, but not more than 55,000 euros, excluding VAT.
